This two-day forum aims to address the continuing and unresolved disputes on the position and application of Islamic laws within our constitutional democracy and propose the establishment of a Consultative Council of Islamic and Constitutional Law Experts.

Background

The Federal Constitution provides for a dual legal system, where civil law governs all Malaysians regardless of religious affiliation, and Shariah law applies to Muslims as their personal law and covers family law matters, as well as a limited area of offences "against the precepts of Islam" committed by Muslims.

The continuing and unresolved disputes on the position and application of Islamic laws within our constitutional democracy reflect a lack of clarity and understanding on the place of Islam within our constitutional democracy leading to a serious breakdown of federal/state division of powers.

Aims and Objectives

- 1. To champion rational and informed discourse on the ways Islam is used as a source of public law and policy in Malaysia
- 2. To address the areas of conflict and overlap in Malaysia's plural legal system between civil law and Shariah law, and in the federal-state division of powers
- 3. To raise public awareness on the legal jurisdiction and substantive limits of the religious authorities and administration of Islamic laws in Malaysia
- 4. To propose the establishment of a consultative process through a Consultative Council of Islamic and Constitutional Law Experts
